Review Drug Court: Dornfeld reported in 2020 we saved a total of over \$76,000 in incarceration costs in participants we had. Due to COVID our referrals were down. 144 hours of community service was served in 2020. Total of 5 participants in the program as of March 8, 2021. Discussion Followed.

Federal Drug Court Grant Application: Dornfeld reported that this year the State grant funding is now competitive. The Federal grant is open and has a deadline of March 31, 2021. Dornfeld reported the State Drug Court grant is not open but should be opening soon. Discussion Followed. Motion/Second (Reabe/Jerome) to apply for the Federal and State Grant for the 2022 grant

Overview of Overdose Fatality Review Team: Dornfeld stated this team reviews overdose fatalities to look to improve the systems and outcomes going forward. 31 partners that are working together in 3 counties, Marquette, Waushara, and Green Lake. Discussion Followed.

Overview of ED2Recovery: Prost a recovery coach and peer support specialist stated that ED2Recovery is a grant that is funded through Health and Human Services and then passed down to UW-Madison the funding then is distributed all over Wisconsin. Discussion Followed.

Election of Chair and Vice-Chair: Christenson called for nominations for Chair of the committee. Motion/Second (Jerome/Slate) to elect Holley Dornfeld for chair of Criminal Justice Collaborating Council. Motion carried with no negative vote.
